**ORDER**

**PROMOTION & POSTING (Head Constable Dog Handler)**

The Director General of Police, Punjab, Chandigarh vide his office order No. 535-49/E-1(5) dated 14.01.2025 has intimated that Ct. Yugraj Singh No. 3/711 & 19 others filed the CWP No. 10367/2024 in the Hon'ble Punjab & Haryana High Court for the issuance of directions to the respondents to consider the candidature and further promote them in the post of Head Constable/Dog Handlers being fully eligible especially in the light of the judgement dated 18.05.2023 passed by the Hon'ble Court in CWP No. 23480/2015 "Mander Singh Vs State of Punjab & Others" as well as order dated 10.12.2013 passed by the their office.

2. The said Civil Writ Petition was disposed by the Hon'ble High Court on 06.05.2024 with the following direction:-

*"...with the consent of both sides, the matter is taken up for final disposal.*

6. *Learned State Counsel assures the court that competent authority would look into grievance of the petitioners and pass an appropriate order in terms of order dated 18.05.2023 passed by this Court in CWP No. 23480 of 2015.*

7. *In the wake of statement of learned State counsel, the present petition stands disposed of."*

3. Therefore, the W/DGP/PB/CHG is directed that in compliance of the above mention order of the Hon'ble High Court, the following Senior Constables who have passed the Dog Handler course up to 12.12.2013 are hereby promoted to the rank of Head Constable (Dog Handler) as per available vacancy:-

4. In view of the above directions issued by C.P.O. Punjab, Chandigarh, a Departmental Promotional Committee was constituted to scrutinize the record of above said officials. As per recommendations of the Departmental Promotional Committee, the following officials are hereby approved for the promotion of the rank of Head Constable (Dog Handler) w.e.f. 14.01.2025 (date of issue of DGP/PB's letter) against the vacancies in the Dog Squad. This approval is subject to the condition that no departmental enquiry, vigilance enquiry or criminal cases are pending against them. On promotion the following

officials are posted to the districts as mentioned against each. Their promotion will take effect from the date of joining at their new place of postings:-

5. All the above mentioned officials who have been promoted against the existing vacancies in Dog Squad will remain in Dog Squad. In case, later on at any stage, someone opts for the general line, their seniority will be determined on the basis of list C-1 viz a viz their counter-parts in general line. Therefore, they will have no claim to seek seniority on the basis of next higher rank of promotion earned against the Dog Squad vacancies.

6. As per instructions issued vide Director General of Police, Punjab, Chandigarh vide memo. No. 14681-91/E-1(3) dated 27.11.13, concerned officials will join at their new place of posting within 30 days from the date of issuance of promotion order, otherwise their promotion order will be withdrawn and they will be considered for promotion after two years.

7. The Punjab Civil Services Rules (General and Common Conditions of Service Rules) 1994 have been applicable w.e.f. 04.05.1994. As per rule 18(2), if any Govt. employee refuses to accept promotion, he shall be debarred by the appointing authority from consideration for promotion for all the consecutive chances, which may occur in future within a period of two years from the date such refusal to accept promotion.

8. This order will further be subject to pending CWP/SLP (if any) in the Hon'ble High/Supreme Court of India regarding seniority etc.

9. Formal orders will be issued by the Senior Superintendents of Police, concerned.
