- 3. The Punjab Civil Services Rules (General and Common Conditions of Service Rules) 1994 have been applicable w.e.f. 04.05.1994. As per rule 18(2), if any Govt. employee refuses to accept promotion, he shall be debarred by the appointing authority from consideration for promotion for all the consecutive chances, which may occur in future within a period of two years from the date of such refusal to accept promotion.
- 4. The Head of concerned district will ensure that the officials approved for promotion are relieved impediately or alternatively they should get in writing within 30 days from such officials that they want to forgo their promotion. This order will further be subject to final decision of CWP/SLP (if any) pending in the Hon'ble High/Supre ne Court of India regarding seniority etc.
- 5. Rormal orders will be issued by the Senior Superintendents of Police/unit concerned.
